Summer Enrichment Early Childhood Program (3-6 yrs as of June 26<sup>th</sup>)**

This Agreement is made by and between Hamilton Park Montessori School, 1 McWilliams Place, Jersey City, NJ 07302 ("HPMS" or the "School") and the parents (the "Parent(s)") listed below for the 2024 Summer Enrichment Program:

I (We) hereby accept a space for my (our) child (the "Student") as a summer student at Hamilton Park Montessori School for the 2024 Summer Enrichment Program as indicated on this Registration & Letter of Agreement.

I (We) understand that the summer enrichment program tuition must be paid in full prior to the start date of the program.

The \$250 deposit (per 2-week session) and balance of the summer program tuition is non-refundable and non-transferable.

I (We) understand that there will be a \$60 swimming equipment fee due prior to my child's start date.

I (We) understand that I (we) will receive a copy of the Parent Handbook before the start of the program for my (our) child. I (We) also understand that I am (we are) obligated to comply with all of the rules and regulations contained therein. Before my (our) child enters the program, all required paperwork will be completed, signed and returned for my (our) child's file.

I (We) understand that the School reserves the right, in its sole discretion, to immediately exclude, request the withdrawal of, or dismiss any student from activities, classes or from the School upon notice to the Parent(s), for any cause whatsoever including, but not limited to, violation of any rules or regulations, or failure to make payment of fees and tuition, if deemed by the School to be in the best interest of the School and/or the Student. The school also expects that Parents will, at all times, conduct themselves appropriately in matters involving the School, Staff, and other Students. If the School dismisses a student, the Parent(s) will be liable for the student's tuition through the end of the program in which dismissal occurs.

I (We) agree to release HPMS and its directors, officers, employees and agents from all claims, causes of action, damages, liabilities, and losses arising out of or resulting from the Student's participation in HPMS programs, to the extent permitted by law, except for acts or omissions involving willful or wanton conduct by a director, officer, employee or agent of HPMS.
